



OPENING STATEMENT

N.A., as we know it, was formed in 1953. In 1959, our fledgling fellowship survived a major crisis. Lack of adherence to the Tr_ditions almost destroyed us. As our fellowship started to grow again the concept of a Board of Trustees was put into action to help prevent this from happening again. In the beginning our Trustees acted as a "Board of Directors", guiding the growth of the fellowship, and safeguarding our Traditions. The Board of Trustees was given the authority to act in this manner until such time as our fellowship could manage its own affairs.

Today, we again stand at a crucial point in the growth of N.A. The stage is set. This is the First world Service Conference. An important event, for the fellowship and for the Trustees, an event which is the result of three years of planning and work. It is, and has been, the intent of the world Service Board to transfer the decision-making process and guidance of N.A. to the fellowship.

In looking back at the last few years, the intent of the Board becomes obvious. The first phase of this effort was to set the scene by training members to take over responsibility, expanding our available literature, encouraging new meetings and service committees and setting up a functioning world Service Office. This first phase is complete. The second phase was to establish a service structure which make it possible for the fellowship to be self guiding. This was the purpose of THE N.A. TREE, to establish a method by which decisions could be made by the fellowship. This phase is well on its way. Our groups have active officers and representatives; area committees and regional committees have been established and are functioning; and we have a world Service Conference. The final phase of this project is the actual transfer of decision-making and guidance from the Poird to the fellowship. This final phase begins today, with the First world Service Conference.





MOTION: Due to the fact that many Regional Committees have not as yet formed and that those which have formed have only done so recently; I move that for this First World Service Conference the World Service Board meet with Area Service Representatives as well as Regional Service Delegates.

PROPOSED PROCEDURE-

- A. Who will be recognized?
 - 1. Any duly elected RSD
 - 2. Any duly elected ASR
 - 3. Arry Trustse
 - 4. For groups outside of California who have not as yet formed Area Committees one spokesman will be recognized from each state, province, or foreign country.
- 3. All others who wish to be heard shall communicate through their Representative. They shall not be called upon from the floor.
- 3. Only ASR's, RSD's, Trustees, and authorized spokesmen shall have a vote on any item considered.
- D. All decisions shall be by majority vote.
- E. There shall be no 'cross' discussion.
- F. The Parliamentarian shall have the right to interrupt the assembly or any speaker whenever such action is necessary to maintain order.
- G. Discussion on any matter shall be limited to a maximum of ten minutes.
- II. We ask that any statements from recognized speakers be limited to five minutes.

One year ago Narcotics Anonymous had again reached a turning point.

Link of communication was evident in the kind of confused questions and

minimal rected letters we received at the W.S.O. Starting from the point of
getting all mail sent into P.O.BOX 622 Sun Valley again was our first
effort. Second was the need to answer all mail and keep a record of all
Starter Kits sent out so that follow up could take place later.

A basic need for more literature had to be met and met at once. Despite many requests to the fellowship, only a trickle of input was coming into the literature committee. We tried, for a number of reasons, to fill this need as quickly as possible. One, we knew that a variety and some different forms of information would help us to grow. Two, since area representation was more widely being initiated, our structure book, talked about for a very long time, had to be published to give some purpose, guidance and unity to the Fellowship as a whole. Three, funds, both donations, little enough at bost and 'One'book sales would not be enough to sustain us through the pransition period which was taking place; the result of funds being used to build up area and regional service arms of N.A. Four, the World Directory, needed for many obvious reasons, had to be completed now. Five, the sixteen year need for, at least, a Spanish translation of our White Book, starting with an 1.P. just had to come about. We had lost the headway we had made in Mexico and South America and all our groups, to the best of our knowledge in these areas had dried up. This had to be changed.

Where are we now? In less than ten months we have 'The Tree', six
English and one Spanish Informational Pamphlets, The World Directory updated
to November 1st '76 and a Complete Group Kit.

After three years of trying to contact the old groups of Drugs Anonymous in Australia we were able to find the new groups, four in number and after some communication they decided to join us as Narcotics Anonymous. Their groups are growing fast, since April'76 they now number eighteen. Starting in Sydney in New South Wales they spread six hundred miles south to Melbourne and the same distance North to Brisbane in Queensland. Two groups have started in Perth in Western Australia and we have every reason to believe that growth will continue. To the North in Canada groups are growing as well as loners. The last request for a Starter Kit and other literature, that we have just received, stating that many are seeking our kind of program, was from Bombay, India.

Since March we have answered all letters, except those now on hand, we have shipped out one hundred and eighteen Starter Kits and answered about eight hundred phone calls from addicts, families, probation officers, nurses, drug abuse programs, doctors and judges. We have done our best to make the proper decisions when they had to be made and will continue to do so.

WORLD SERVICE BOARD GUIDELINES.

1.

In our Fellowship the Traditions praceeded the Trustees so our policies were at work to direct and guide Our Trustees as they were duly selected and appointed in the begining. Since then our Trustees are men and women who have, for the most part, exhibited certain qualifications necessary for Trusteeship. Cualifications alone do not always make an admirable Trustee but from basics we can grow in experience and wisdom. Qualifications that have become accepted and followed in the operation of the Fellowship to date are these.....

- 1. At least 5 years total abstinence.
- Service experience as shown in their commitment to their Group, area or region.
- Working knowledge of and meaning of all of our Traditions.
- 4. To have Time, Capability and Resources neccessary for Trustee service.
- 5. To be willing to serve.

The number of Trustees at present seems adequate, too many could become unwieldy and just as confusing as at some times in the past. At present, we the SERVICE BOARD OF TRUSTEES are the direct and directive service body of N.A.

Since this at times seems to imply a governing body, though it is not really so, then we must continue to encourage, in all quarters, the formation of representation groups at all levels of service. We will continue to act in good faith and in full adherence to the Traditions at our level until other service bodies, as laid out in 'The Tree' appoint or elect their Belegates to meet with us at the Conference Table. We must, of course, exert utmost flexibility at this level for some time so that legal and proceedural methods may be worked out to ensure the utmost unity in our efforts. We trust that these can be as simple as possible yet sophisticated enough to protect us from ourselves and others.

our membership has grown and capable people are appearing who can assume active roles as Chairpeople and Officers at their levels of service; then perhaps our Trustees can give more of their time to the needs of their Trusteeship.

In the meantime, in order that, we the present Trustees can better serve our office, some more definitive guidelines are needed. These need not be comprehensive but they should be a clear exposition of our adherence to the Traditions as a primary base from which to grow. Time and the needs that arise will determine more fully our goals and our capacities. To anticipate the needs and initiate the means to enlarge and strengthen our Fellowship, if not the first goal, then is certainly close to it. To this end let us lay out some simple proposals to take care of some of our needs.

All present Trustees are permanent but are subject to the following......

- A. Loss of abstinence results in automatic removal from office.
- B. Removal for due cause; at Conference level. N.A. membership is not affected.
- C. Resignation by Trustee.
- D. Trustee may request leave of absence or non-active status when warranted.
- E. Death of Trustee.

How do we replace? Now that our Structure is guiding our Fellowship in more areas than ever before, we sixuald start with qualifications from page 1 #s lto5. Nominations should come from the World Service Board Of Trustees and/or Conference Delegates.

GENERAL HESPONSIBILITIES OF BOARD OF TRUSTEES MEMBERS.

All Trustees to work with GENERAL SERVICE DELEGATES ON GENERAL SERVICE CONFERENCE level when and as soon as they are duly elected and ready to assume responsibility. This November may be the begining of the true SERVICE STRUCTURE. There we can work out proceedures for future conferences, with we hope a minimum of personality problems. As was previously stated, let us remain flexible during this period of construction. Let us follow 'The Tree' and perhaps all can attain maximum benefits.

Principally we are here to safeguard N.A. Traditions, to be responsible for service funds, to oversee service units, service staffs and all functions of present and future units.

Trustees are members of GENERAL SERVICE CONFERENCE and are co-responsible with the GENERAL SERVICE DELECATES in all decisions affecting overall service.

That end, to which all our efforts should be directed, is our first goal; 'To carry the message to the ADDICT who still suffers.' in whatever way is dictated by our conscience and our experience.

To remember that only with GOODWILL can we be TRUSTED SERVANTS and not authoritarians.

FIRST WORLD SERVICE CONFERENCE Ventura California November 13, 1976

The First World Service Conference resulted from several years of phone calls and letters among members of the Fellowship interested in developing greater unity, better communication and expression of the group conscience of N.A.

The Conference included participants from 14 States and 2 Foreign Countries. There were 37 participants in all. The Conference lasted $1\frac{1}{2}$ days. The notes and minutes (of sorts) that were taken of this first Conference are imprecise and lack great detail.

The general result of this first Conference was to formulate Committees to work more diligently on new N.A. literature and a Book on Recovery and also to develop more clearly the guidelines, policies and Structure of N.A.

No specific record was kept of the motions made at this Conference.
