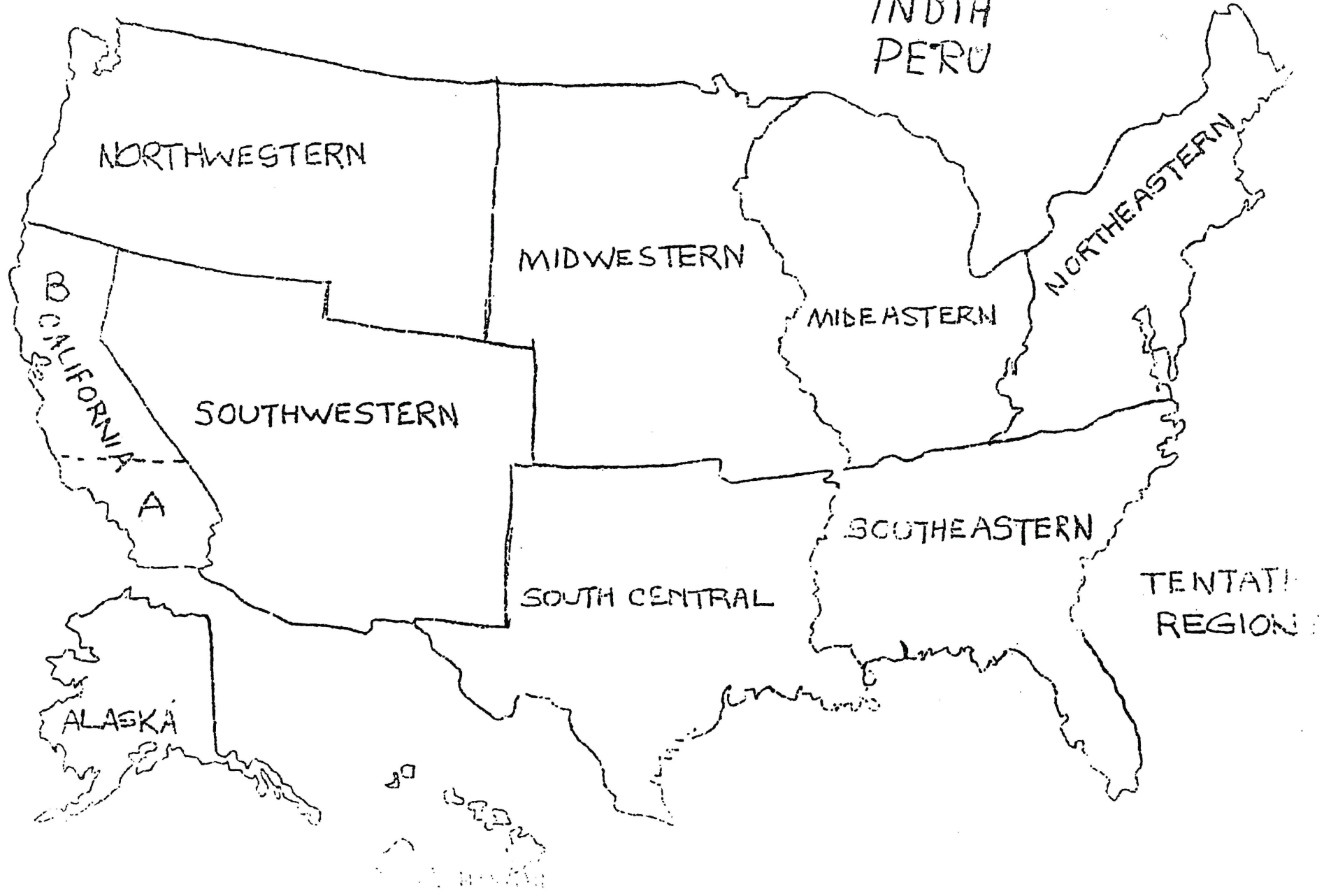

Dear Friends,

Well, the Seventh World Convention has come and gone and as always it was great. The San Francisco Convention Committee did a super job, and their dedication showed. Next year... Houston, Texas! Fantastic! And probably one of the best things that could happen for the growth of N.A.

The real purpose of this letter is better communications and to let you know what happened at the World Service Conference. The WSC was called to order at 12:30 p.m. on October 21, 1977 as planned in the agenda. At that time only three trustees were in attendance (none of the Regional Delegates or other trustees had, as yet, arrived). Because of this poor showing the Conference was adjourned until 2:30 p.m. in the hope that more participants would be there at that time. When we reconvened we had gained one trustee, two Delegates and one Regional Chairman (sitting in for his absent Delegate). We opened up the Conference for discussion and the consensus was that this showing was not representative of the fellowship and that the Conference should be postponed until a later date, separate from the convention. The dates March 25 and March 26, 1978 were chosen and the World Service Office will make the arrangements.

The plan is to keep the Conference as simple as possible. A meeting hall, some basic refreshments, and some housing will be arranged for; beyond that, the Delegates will be pretty much on their own. The two day Conference will be broken up into four morning and afternoon sessions. These sessions will focus on Old Business, Committee and Problem Workshops, New Business, and Planning. There won't be any special activities or social events planned for the Conference, however, numerous regular meetings and activities are easily accessible to Conference participants. It's my hope that someone from each of the forty-seven states and countries where meetings are held will be able to attend this Conference.

N.A., as we know it, started here in California, and for twenty years there were only a few groups elsewhere. In the last five years, however, islands of fellowship have surfaced and grown. Today we have strong, active groups in many places and N.A. is growing faster than it has ever before. This is the underlying reason for trying to get a "Conference System" going at this time. As long as we remain isolated clusters we'll keep re-experiencing the same problems which have always stunted our growth. If we can really get together in a united

fellowship, work together to carry the message of recovery as it's never been carried before, be mutually supportive rather than separate or competitive; then we can see more growth in the next two or three years than we've seen in the last twenty-five. This is part of my dream for N.A.; maybe it's only that, but it makes me feel good to think that it can happen. I hope that each of you in your groups, your Areas, and your Regions will help make this dream a reality. I hope that you'll get behind this idea and do whatever is necessary to get your Delegate to Los Angeles in March. I dream of Narcotics Anonymous as a strong, united, vital, living, growing fellowship coming out of its infancy into its full potential.

PROPOSAL - CONFERENCE COMMITTEES

- A. That the following Conference Committees be established to work for the benefit of the fellowship until the next Conference.
 - 1. Coordinating
 - 2. Planning
 - 3. Finance
 - 4. Literature Review
 - 5. Institutional
 - 6. Public Relations
- B. That these committees shall consist of an odd number of members from various regions. (No committee shall have a predominance of members from any one Area or Region)
- C. That the Committee members shall have the following qualifications:
 - 1. The willingness, desire, and ability to serve
 - 2. A history of sobriety
 - 3. Relative experience or ability
- D. That the affairs of each Conference Committee be managed by the following officers:
 - 1. One Chairman
 - 2. One Secretary
 - 3. One Trustee
- E. That these Conference Committees be established as soon as possible by the following procedure:
 - 1. Each Committee Chairman and Secretary be nominated and elected by this Conference
 - 2. That a Trustee be appointed by the WSB to serve on each Committee
 - 3. That the three officers of each Committee select additional Committee members by majority vote
 - 4. That members wishing to be considered for Committee service complete and submit the attached application
- F. That these committees shall meet formally at least twice prior to the next conference; and that close contact be maintained at other times by telephone or mail.
- G. That all Conference Committee decisions and recommendations be determined by majority vote.
- H. That a copy of the minutes of all Conference Committee meetings be kept on file in the WSO and be made available to any member on request.
- I. That each Conference Committee prepare and present a report at the next World Service Conference.
