This report to the Fellowship includes reports from all of the sub-committees of the Conference, from the Board of Trustees and the World Service Office. This information on the activities of the Fellowships service arms will be helpful in keeping the Fellowship informed of the vital activities and process on

and sub-counteress in this monthly Pellowshi

projects currently being worked on.

There is however a limitation that these quarterly reports impose, with respect to speedy and complete communication within the Fellowship. There has been a tendency to rely singularly on the three "Fellowship Reports" as the only time sub-committees or other service arms communicate to the Fellowship. This has encouraged RSR's to expect that these quarterly reports are the only matters from Conference sub-committees that they are required to distribute to each group in their region. As an additional matter, the reports have become so lengthly that they are expensive to reproduce and mail.

With all the information coming in one package, the Fellowship at the Group level has had to inconvenience their routine meeting agenda to take time to conduct a lengthly

discussion to all these matters.

The simple fact is that there is too much going on in the Fellowship to depend on these quarterly reports as the only, or principal means of communication. The disruption that the bulky report causes throughout the Fellowship can be avoided and more timely distribution of information can be created. Consequently the form and frequency of communication will change during the months ahead.

This will be the last informative quarterly report distributed in this manner. All service arms and sub-committees will begin to use a bi-monthly report system. The sub-committees will be assigned a schedule, so that each committee reports to the Fellowship on a bimonthly basis. The Fellowship, in this way will begin to receive the same basic information, but in more digestable sizes. Additionally, the information will be more timely.

For matters that will be submitted to the Fellowship prior to the next Conference for possible adoption, a bulky report cannot be avoided. All matters that will be submitted to the Fellowship for group conscience and possible adoption at the World Service Conference will be contained in one report and mailed to the WORLD SERVICE CONFERENCE
OF MARCOTICS ANONYMOUS

Fellowship 90 days prior to the Conference.

The WSO has consented to changing the format of their NEWSLINE, and including official reports from other service arms and sub-committees in this monthly Fellowship publication. This new policy will be initiated with the August NEWSLINE. The NEWSLINE is already mailed to over 2,000 members of the Fellowship. Among these addressees are all of the Conference participants, the RSR's, WSC Officers and Committee members. Each new group that registers is added to the list and as information is received on new addresses or contacts for existing groups, they are added. Hopefully every group will eventually maintain a current mail address and will thereby be able to receive this important Fellowship information directly.

A tremendous savings in time, energy and expense will result from this new policy.

Another important change has already been implemented concerning control of mail and telephone calls to WSC officers and sub-committees. In previous years, a list of home phone numbers and addresses of WSC officers and sub-committee chairpersons was made and distributed openly throughout the Fellowship. This frequently resulted in calls at all hours of the day or night. It also resulted in calls missed because the desired person was unavailable or there was not an answering machine. There have been occasions when the person called was not responsible for the matter the caller desired to discuss.

A new telephone number has been installed in the World Service Office for the purpose of receipt of calls that were previously made to individual WSC officers or sub-committee chairpersons directly. During the working hours of the day, the WSO staff will answer this number and take messages for the person desired. An attempt will be made to make certain that the person desired is the one responsible for the matter of concern. During the evening hours the number will be served by an telephone answering machine. During the day, as previously arranged with respective individuals, the WSO will call to convey all messages received in the past 24 hours. In this manner calls will not be missed and trusted servants will have opportunity to respond to their duties without untimely calls.

The new stationery of the WSC, as you can see does not include the full list of addresses either. A new policy has been initiated whereby all mail will be directed to the appropriate person, through the WSO. This has been in operation for about 60 days and has worked well. The Fellowship is requested to address all correspondence for the Conference officers and sub-committees to the WSO. They will forward all communications to the appropriate individual.

The Minutes of the 1984 World Service Conference were recently mailed to all Conference Participants. The Minutes mailed are the corrected Minutes of the Conference. The tape recordings of the Conference were reviewed and some changes are thereby reflected in the Minutes from the draft Minutes available at the Conference. These Minutes will be considered for approval at the Conference in 1985.

The Revised Temporary Working Guide to the Service Structure is almost complete and will soon be available through the WSO. The Revised publication will include actions taken at WSC 83 and will reflect changes adopted at WSC 84. New guidelines were adopted by the Conference for the Trustees, for Literature work and a new section on finances and the Fellowship magazine.

Attached is a special report to the Fellowship containing matters acted on by the Conference in April in which the decision was to seek additional Fellowship Conscience. The Fellowship is requested to review these items and advise their Regional Service Representative of their group conscience. These matters will be eligible for consideration and possible adoption at WSC 85, without requirement for additional notification or inclusion in the report to be sent to the Fellowship 90 days prior to the Conference in 1985.

An important action of WSC 84 was the establishment of a "Select Committee" for the revision of the Service Structure and the development of a Service Manual. This Committee chaired by past WSC Chairperson Robert R. is responsible for the drafting of a single publication containing our Service Structure and a comprehensive message on service. The committee is composed of four Trustees and four current or immediate past RSR's. Among these members also are three current or past WSC officers. Of the committee members only two have less than five years clean time while the average time is six years. The Committee is balanced geographically, with members from across the Fellowship.

The Committee was instructed by the Conference to present a draft to the Fellowship this year, in November. The Committee had a brief meeting at the Conference and a meeting in June. There are two meetings scheduled in the months ahead. The committee is working on input submitted at the Conference and prior to the Conference. The Committee did not receive input from RSR's at the Conference specifically on the group conscience from each region. RSR's are requested to send to the Committee, addressed to the WSO, as much detail as they have available to them on the group conscience of their region on the proposal that was submitted to the Fellowship in February. This information would be very helpful to the Committee in determining direction and concepts that the Fellowship desires or rejects.

Everyone in the Fellowship must certainly be aware of the staggering growth the Fellowship is experiencing. This is definitely a blessing as the more the Fellowship grows, the stronger N.A. becomes. Growth is not, however, without its difficulties. The Fellowship is no longer a small, almost lethargic collection of meetings confined to the Los Angeles area. It has grown to include over three thousand groups and new regions are formed each year, two in the past month alone. This sets the stage for confusion and controversy in the decision making process for the Fellowship. As the Fellowship matures, the questions concerning procedure and policy of Conference operation are refined and codified. As we grow, we have tried different methods and procedures as new problems and circumstances arose.

Last year for instance, the Fellowship was asked for an emergency concurrence to permit omission of several stories from the Book because copyright releases had not been obtained. This year, another emergency request has been dispatched to the Fellowship asking for instructions on proposed change in the Book to the explanations of Traditions Four and Nine. Although these procedures are not outlined as part of the decision making process of the Fellowship, they have been used in order to involve the Fellowship at the Group level in decisions that affect N.A. as a whole, which could not be held in abeyance until the next Conference.

These circumstances have highlighted several particularly troublesome issues that the Fellowship needs to address its group conscience to: 1. What are the proper bounds of the authorities the Fellowship desires to invest with "trusted servants" and 2. In what circumstances does Fellowship group conscience mandate trusted servants to refer emergency decision to the full Fellowship?

An example of these problems was action taken by the Conference to discontinue sales of several pamphlets when the Fellowship had not been asked in advance concerning the discontinuing of sales on these items. Was this within the bounds of authority the Fellowship intends for the Conference to have.

In a more recent situation arisen since the end of the Conference in April, the Literature sub-committee has found that several of the stories directed by the Conference to be included in the Third Edition of the Book are filled with incorrect punctuation, poor grammer and in the case of one story containing suspected Tradition violations. Should the stories be excluded from the Book? Should the stories be "corrected" by the Literature sub-committee? Should the stories be submitted to the Fellowship for an emergency decision? or should the stories be printed, errors and all?

These questions highlight the procedure used recently with respect to the language for explanations in Traditions Four and Nine. Although the vote to send this to the Fellowship in the manner it was, received approval of the Conference on a vote of YES - 40, NO - 0, the procedure is not outlined in the existing service structure. Was this an appropriate use of the authorities of the "trusted servants"?

With the current rate of growth or at an excelerated rate, as may well be expected, the number of groups will quickly reach 4,000 and soon thereafter 5,000, then 6,000. At what point does it become impractical to take such matters to each group for decision?

There is already a growing number of complaints that more and more time in groups is being taken up by these business matters and diverting from the duty and purpose of meetings which is recovery. Many have said there is already enough business being conducted at the group level and little enough time to spend on discussing the steps and applying them to our daily lives. N.A. is a spiritual Fellowship that some are saying has become embeded with the routine business a large corporation would have assigned to corporate officers and chief employees.

The Conference and other Trusted Servants have at times taken action on their own or in concert to make decisions on matters of N.A. affairs. There is a continuing unresolved discussion each time such decisions are reached concerning the questions posed above: is this decision within the scope of authority the Fellowship desires trusted servants to make or is this a circumstance where the Fellowship expects the matter to be

refered to a Fellowship conscience?

Having in the paragraphs above detailed the dilemma, there are two specific issues that were handled in separate manners that the Fellowship has begun to make comment on. The Guide to The Fourth Step Inventory was withdrawn from publication on the basis, as evidenced by vote of the Conference, that the Conference participants (as trusted servants) felt the Fellowship had vested them with the authority to make a decision. Although there are some who may disagree with the decision because of the specific publication in question and some may disagree with the exercise of the authority in principle, regardless of the publication in question, a majority of the Conference as a whole felt their action was proper. On the matter of the change in language of the Fourth and Ninth Traditions, the Conference vote evidences the viewpoint that the Fellowship as a whole should make the decision to change the Book. Perhaps the distinctions drawn here can be an appropriate guide to answers of the questions posed.

In closing, I'd like to express my feelings of gratitude to the Fellowship for giving me the opportunity to serve the Fellowship as Chairperson of the Conference. It is with a prayerful heart and spirit of fellowship that I pursue the tasks assigned to me. I ask for your prayers, support and suggestions for the advancement of N.A. and our ability to carry the message to the still suffering addict.

SPECIAL REPORT ON CONFERENCE PROPOSALS
THAT WERE REFERRED TO THE FELLOWSHIP

TO: THE FELLOWSHIP

At the World Service Conference meeting held in April, there were a number of motions made that were not approved or disapproved by the Conference. These items were referred back to the Fellowship. In order to fulfill the intent of the action to refer these motions to the Fellowship, this report has been prepared.

In the following paragraphs, the language enclosed in quotation marks contain the actual language of a motion that was introduced but referred to the Fellowship. The language not enclosed in quotation marks "...." and the language contained in brackets [....] is information that may be helpful to understand what took place and to aid in review of the proposed motion. These motions are not presented in the sequence of their introduction at the conference, but have been matched with motions related to the same area of concern. The formation of a Select Committee to take over the responsibility of creating a draft Service Structure might well have superceded the necessity of having some of these motions that amend the Temporary Working Guide, from having to be sent to the Fellowship, but because that was the action taken by the Conference, at the time, they are encluded for your information at least. All of them were also referred to the Select Committee for their consideraton.

These first two motions relate to the Trustees and would have changed the language of the Temporary Working Guide, as it was amended by adoption of the section related to Guidelines of the Board of Trustees that had been sent to the Fellowship in February.

(1) Page 19, E. 1. Board of Trustees section, After nominated, add and affirmed by the Region in which they are a member."

(2) "Page 18 Section 4A-1 after the word "ultimately add a minimum of 12 active trustees to conduct business and paragraph A2 that at least 5 non-voting alternates for the Board of Trustee member in order to provide:

A. A training ground and continuity of experienced trustees.

B. Assistance for each of the proposed WSB subcommittees and for assistance with the volumes of work to be done in subsequent years.

C. Consistency to our service structure from group levels (GSR's and GSR Alternates) the areas (ASR and ASR-Alt) The Region (RSR and RSR-Alt)."

The following motion proposes to amend the Service Structure in order to provide a procedure for removal of trusted servants when necessary.

- (3) "To amend the TEMPORARY WORKING GUIDE TO THE SERVICE STRUCTURE to replace `Any ASC member or officer may be removed during their term in office by a majority vote of the ASC' with `ASC Officers and Committee Chairpersons may be removed from office for the following reasons:
  - 1) Involuntary Resignation
- 2) Missing two or more consecutive ASC meetings without reasonable cause.
  - 3) Relapse and the moltage with the support and the last
  - 4) Breach of the Traditions that is unreasonable.
  - 5) Impeachment 2/3 majority by closed ballot
- V. Voluntary resignation should be given to ASC Chairperson in writing at least 7 days prior to the next ASC meeting."

Concern was expressed by numerous RSR's on the length of time that had been available for the Fellowship to review the material sent in the review packet in February. This was expressed in efforts to lengthen the time that the material would be available prior to the Conference. Two of those motions were referred to the Fellowship even though the Conference adopted a motion that did extend the time requirement. The motions referred to the Fellowship were:

(4) "to replace 120 days with six (6) months". [An effort was made to limit this input requirement to committee reports and that motion read]:

(5) "that any input be changed to read, `any sub-committee input'". [The action related to this issue that was adopted now requires that WSC send material for Fellowship review not less than 90 days prior to the Conference.]

There were a number of different motions related to Literature and Literature approval. Those adopted or defeated will be reflected in the Minutes of the Conference. These were the only motions referred to the Fellowship.

(6) "That the Conference approve the revised version of "Another Look" IP." [This motion prose from the report of the WSC Literature Committee Chairperson that indicated the language in the currently printed pamphlet is different from the language circulated prior to its approval by the Fellowship several years ago.]

(7) "That the IP "A Guide to the 4th Step" be disapproved and removed from circulation and that all remaining inventory be destroyed immediately." [A motion of substantially the same language was introduced at the conference, after this one was referred to the Fellowship. The subsequent motion was adopted and the pamphlet has been withdrawn from circulation.]

Several motions were introduced pertaining to the proposed adoption of the "Do's and Don'ts", which would be added to the currently approved H. & I. Handbook. They are:

currently approved H. & I. Handbook. They are:
(8) "To approve the `Do's and Don'ts` as an addition to the
H&I Handbook." (7) "To amend the H&I `Dos and Don'ts` as follows:

Do's: #3. Add `Who is an Addict?'

#12. 12th Step Only

Don'ts: #2. Should say `take' instead of `allow'

#7. Delete

#9. Emphasize total abstinence

#15. Change 'One Day at a Time' to 'Just for Today.'"

- (9) "To amend `don'ts' -Deleted: `interact'
- (10) "On 'Do's', #3 DELETE Twelve Traditions."

The final action on motions related to the Do's and Dont's was:

(11) "To commit 'Do's & Don'ts" to WSC 1984-85 H&I sub-committee with input from this conference." [The new H. & I. Committee has received these proposed motions as input, but because the motions that were first acted upon instructed that they be sent to the Fellowship, they are included here, at least for your information.]

There were three motions concerning the World Service Office that were referred to the Fellowship. They are:

(12) "So as to allow for complete fellowship representation on the WSO Board of Directors, be it moved that travel expenses be provided for WSO Directors to attend Board meetings paid for by WSO." [As a result of budget appropriations made by the Conference and a shortfall in projected income, the WSO is being asked to make up the difference in WSC expenses. The majority of the WSC budget is for travel expenses of selected individuals whose importance at certain meetings of the Fellowship is so important that the Fellowship should pay for the expenses.]

(13) "That the WSC urges the WSO to publish a softcover edition of our Book in addition to a hardcover edition."

(14) "Welcome keytags be changed to read 'Just for Today', and that all tags be consistent in color." [The change in color of key tags resulted from a change in manufacturers and the fact that

the new ones were mixed with the old ones rather than sending out all of the old type first. Additionally, the new manufacturer's orange was so close to their red that confusion arose frequently and it was found easier to make a major shift in color from the "new orange" to the current color. The old manufacturer was charging 7.5 cents more for each key tag than the new supplier. A five cent saving was passed on to the Fellowship in a price reduction last summer when the change was originally made.]

Several motions were introduced concerning the Annual Fellowship Convention. The two motions below were referred to the Fellowship prior to action to create a standing Committee of the World Service Conference on Conventions. The Convention Committee has accepted the motions as input to their deliberations, but the motions are presented here for information.

- (15) "On page 51 [of the blue proposal packet pertaining to the language proposed about the convention], amend World Convention Section at this Conference to give guidance for the distribution of surplus funds and the selection of future locations for the World Convention."
- (16) "Fellowship Report, Volume IV, Part I, Policy Report, page 51, paragraph 5, to replace the percentage of surplus from the World Convention to be distributed as follows:

50% to the World Service Conference

50% to be forwarded to the Region that has been selected to

host the follwoing convention.

INTENT- To use funds generated by a world function to support world services and perpetuate the world convention without undue financial strain up front. However, the opportunity to serve the Fellowship as a whole and not the possibility of financial gain should be the primary purpose of the convention."

After the Conference has decided to send the proposed revised service structure to a select committee, another motion was introduced which would have provided advice to the committee:

(17) "To tak a simple yey/nay vote on the major conceptual changes presented in the WSC Policy Report in order to guage the Fellowship's group conscience and act as an aid to the ad-hoc committee in compiling the subsequent report."

The language of the existing Service Manual suggests that the action to refer an item to the Fellowship for group conscience is intended to provide opportunity for the Fellowship to review the matter before the World Service Conference acts on the matter. In this manner the Conference majority can avoid acting on an item that the majority feels the Fellowship has not previously reviewed. These 17 items are reflected in the Minutes of the Conference as having been sent to the Fellowship for group conscience. They are presented here in this single report in

order to provide opportunity for careful review.

Although each of these items could properly be brought up for adoption at the next World Service Conference, the fact that for several of the matters, a subsequently adopted motion makes action on the some of the motions unnecessary.

The Fellowship should review them and provide instructions to their Regional Service Representative sent to the WSC in Spring 1985 in case these motions are reintroduced in the exact or similar wording.

#### Dear George:

The votes received on the proposed change in the language of the 4th and 9th Tradition explainations were opened and counted today. There were 46 votes received within the required time: postmarked on or before July 15, 1984.

The number of votes: YES - 38, NO - 8, NO ABSTAINING VOTES.

There were 47 voting participants at the World Service Conference in April 1984. The 38 votes cast in favor of the change is 80% of the total number of conference participants.

In order to eliminate controversery in advance, there were 28 regions or other recognized voting areas that cast votes. Of those 28 voting, the count was: YES 23, NO 5, NO ABSTAINING. The 23 votes cast in favor of the change by regions represents a vote of 71% of the 32 regions that were voting participants.

The tally of votes was observed by Dutch H., Trustee and a member of the staff of WSO. The ballots have been kept and are on file in a fire safe cabinet at WSO.

## WSC-LITERATURE SUB-COMMITTEE FELLOWSHIP REPORT #1

Dear Fellow Members:

Thank you for the opportunity to serve as Chairperson of the WSC-Literature Subcommittee again this year. I am grateful for the love and support you have shown me and I will do my best to give you another productive year of carrying the message in written form.

Since our last meeting at the World Service Conference - '84 we have instituted a Literature Review Committee through the direction of the ad-hoc committee which was formed for that purpose. The members of this special subcommittee, as well as the Registered Active Members of the WSC-Literature Subcommittee, are evaluating the following drafts at this time:

It Works: How and Why

An Approach to the Fourth Step Inventory

The Use of Medication in Recovery

Professionals in N.A.

Welcome to N.A.

Living Clean

The Loner: Staying Clean in Isolation

Promises of N.A.

These members are providing input on the above pieces which will be workshopped at our annual November meeting. At that time we will determine which of these drafts to be distribute to the fellowship for review and input.

The WSC-Literature Subcommittee held a workshop in Knoxville, Tennessee, June 27th through 20th. The purpose of that workshop was to finalize the step/tradition draft tentatively entitled IT WORKS: How and Why. As noted above, the draft is now being further evaluated by the Literature Committee before a Review Form is compiled at our November meeting. If all goes well, our

plan is to distribute the review Form to the Fellowship for input around Christmas of this year.

There are three pieces of Review Literature currently in distribution. These are:

Handbook for N.A. Newsletters

Revised - Physician's Viewpoint on the N.A. Program and the Basic Text

Self-Acceptance

The Literature Committee would like each region, area, group and member to read these new pieces of Literature. When doing so, please consider the following questions:

Is the material acceptable as is?

- 2. What should be added (attach specific language)
  - 3. What should be changed (be specific)

4. What should be deleted?

5. Should this project be discontinued?

The above pieces were distributed to each region shortly before WSC-'84. If your RSR or Regional Literature Committee does not have copies, they may be obtained from the WSO at no cost.

Other works-in-progress include a daily meditation guide, a pamphlet to addicts in the armed services, an updated revised version of the Literature Subcommittee handbook and pamphlets to be entitled Total Commitment, and Cooperation Not Affiliation. We have recently completed proofreading the typeset material for the third edition of our basic text. We are continuing to work with the WSO in a spirit of cooperation to further our

primary purpose.

Included with this report is an Approval Form of the pamphlet titled Another Look. As we indicated at the World Service Conference the version of this I.P., as it is being distributed by the WSO is not the version which was submitted by the World Literature Committee for approval. There are only two changes both in paragraph 4. Copies of this section were distributed at WSC - 84' to be brought back to the fellowship. At WSC - 85' we

will request a vote to either approve or disapprove.

There is one other item which the Conference directed us to put out to the fellowship for input. This involves changing the word "recovered" to "recovering" wherever it appears in our N.A. literature. We have done some preliminary research on this matter, and discovered that this word appears only in "What is the N.A. Program?" However, it should be noted that changing this section would involve changing the basic text, the little white booklet, I.P. Number 1 and any other literature which includes "What is the N.A. Program?" Please ponder these questions and send your input to the WSC-Literature Subcommittee. Based on the input we receive, we will make a recommendation to the next World Service Conference.

In addition, it has been suggested that all references to multiple addictions be deleted from N.A. literature to determine the number and locations of all such references. We will present this additional information in a subsequent fellowship report.

I am grateful and delighted to report that the work of your WSC Public Information Subcommittee is well underway! In the months since the WSC, we have been working together to meet our responsibilities to the Fellowship and the still suffering addict. As stated in our report to the Conference, our initial task has been basic organization and planning of PI work at the World level. We saw our responsibilities as being divided into two main areas: as a resource to area and regional PI subcommittees; as an information source to the outside world. We realized that we did not have the materials, resources or guidelines to help us meet our responsibilities. Thanks to the hard work of subcommittee members, guidance and support from members of the Board of Trustees and the WSC Administrative Committee, we are making tremendous progress twoards meeting our responsibilities.

As many of you know, drug abuse and programs of recovery have been in the news at the national level during the past couple of months. Narcotics Anonymous has been mentioned in articles appearing in such publications as <a href="Newsweek">Newsweek</a> and <a href="Rolling Stone">Rolling Stone</a>. NA was minimized in these and other articles. As Chair of WSC PI, I drafted a letter to these publications. The letter was revised during discussion with the WSC Chair, the WSB Chair and the Executive Director of the WSO. The purpose of the letter is to inform these major publications of the growth of our Fellowship and to encourage them to contact us for future articles.

The above situation made it very clear that we need to develop basic information packets and cover letters that can be sent to a national publication introducing Narcotics Anonymous. Rather than having to react to particular articles, our intention is to establish guidelines and create materials that will effectively inform the media and the public about NA.

Over the past months, we have received letters and phone calls from PI chairs around the country requesting information, guidance and materials for use in their regions and areas. Much of the work that is planned during the upcoming year is aimed at providing this kind of support to our Fellowship.

Now that I've given you a general idea of what we're doing,

let me tell you how we're planning to get the job done.

Prior to our PI Workshop July 21-22, several members of the subcommittee drafted an Input Questionnaire and a Census Questionnaire. These questionnaires are designed to gather the information we need to do our work effectively. both questionnaires were finalized at the workshop and are included with this report for your immediate use.

WSC PI Subcommittee Workshop - July 21-22, 1984 Boulder, Colorado

The Workshop was a tremendous success! Not only did we get a lot done, we managed to do it in an atmosphere that was loving and supportive.

We divided the tasks between three committees at the Workshop:

- Census and Input Questionnaires and Information Packet;
- 2) Policy and Procedures
- Audio Visual Review

Following are reports from each of these committees:

Committee 1: Census and Input questionnaires, Information Packet
The work for this committees is included in the Fellowship Report. The members of this committee worked hard to come up with these materials and the quality of the questionnaires reflects their efforts. Lack of time prevented the committee from finalizing materials for the Information Packet. However, work on the packet will continue over the next few months. Committee 2:

WSC PI Subcommittee - Policy and Procedures

In accomplishing the tasks assigned for the Policy and Procedure committee, we were continually amazed at the atmosphere of peace and calm which seemed to surround us. The individuals involved seemed particularly suited to each task, and their talents and creativity are reflected in the draft material we presented to the PI Subcommittee as a whole on sunday. add at one not alki rette but engabling

- b) an addendum stating the interrelationship between the WSC PI Subcommittee, the WSC Administrative Subcommittee, the World Service Board of Trustees and the WSO;
- c) a list of all programs designed to accomplish the functions of this subcommittee;
- d) an addendum pedicting media outlets available to world, regional and area PI committees.
- 2) A list of informational material needed in order to implement PI services and to fulfill the stated functions of the WSC-PI Subcommittee.
- 3) A suggested list of "Do's and Don'ts" for Area PI Service.
- 4) Input for the task force assigned to create a PI handbook.

All of the above work needs additional revision and review,

but we feel we made an excellent beginning.

The suggested Do's and Don'ts are included in this Fellowship report to allow each member to share their experience with us. Any ideas or suggestions on these should be sent to the WSC-PI Subcommittee c/o WSO.

A final draft of the Do's and Don'ts will be submitted during our November workshop and be presented at WSC 84-85 for conference approval.

#### Committee 3:

The Audio Visual Committee's purpose, as defined in Boulder, was to view, review and catalog existing audio-visual material for the Narcotics Anonymous fellowship and, through that process, develop ideas and a mechanism by which we can produce world level Audio Visual Aids for Public Information.

Each piece of material was viewed by the whole committee, discussed and rated on the following scale: Poor - 0 points, Fair - 1 point, Good - 2 points. Each was rated in the following areas: Overall message, script, appeal (to whom and/or what addict type) and production (overall finished product.)

Overall we viewed 7 various radio-TV spots and one 24 minute

Overall we viewed 7 various radio-TV spots and one 24 minute documentary. We found most of the spots had potential but they lacked the quality production required for national exposure. We feel that the only viable way to get this type of spot is to have it professionally produced. A special task force made up of PI Chairperson and Vice Chairperson, WSB Chairman and WSO Executive Director will be researching this area.

## 800 number

I would like to take this time, also, to inform the fellowship that a very thorough investigation regarding use of an 800 number system had been made prior to our meetings in Boulder. After consideration of the issues involved, especially cost, the members of the committee felt that this project is not feasible for NA at this time. This by no means implies that we do not share the Fellowships feelings and concern about the need for an 800 number. An 800 number might simplify the matter of Public Information when dealing with national media. However, to justify the cost involved, our hotlines across the country would have to be fully staffed, and functioning properly to handle the resulting referrals. The hotline/helpline materials we have received so far from various areas and regions indicates that much work is being done. I am sure, with continued hotline upgrading and creation of additional materials by the WSC-PI subcommittee, we will be in a position to reevaluate and consider use of the 800 number system. wallow sach macher to share the

#### Audio/Visual Materials

A special task force consisting of the PI Chair, Vice Chair, WSB Chair and WSO Executive Director will be formed to research production of spots and the editing and possible use of <a href="#">The Survivors</a> video (a 24 minute tape). A report will be submitted by this special task force at the November PI Workshop.

#### Collation of data received from Input and Census Questionnaires

The Questionnaires should all have been received by October 15 and the input will be analyzed and a report made at the November PI Workshop.

## Information\_Packet

An appointed committee will develop an information packet including sample cover letters introducing PI Subcommittees as sources of viable information regarding recovery from addiction through Narcotics Anonymous. Materials to include in this

### List of National Media Contacts and Professional Organizations

Members of the Subcommittee will begin the compilation of names and addresses of magazines, newspapers, professional organizations and agencies. Once an information packet is available, this list will be used as the basis of a comprehensive public information program.

#### Next PI Workshop

The Subcommittee voted to hold our next Workshop November 2, 3, and 4th. We hope to be able to finalize a location by mid-August. Three members of the Charleston, West Virginia Fellowship are exploring the possibility of hosting the workshop in their area. The Subcommittee unanimously agreed that West Virginia would be a great place for the November Workshop. If the three members in attendance in Boulder reflect the willingness and spirit of the West Virginia Fellowship, we couldn't go wrong!

In closing, special thanks are in order. First, a warm and heartfelt message of gratitude to the Boulder and Denver area Fellowship for hosting the Workshop. And thanks to the individual NA members from all over Colorado for participating so effectively in the work of this Subcommittee. The attendance of the Denver Area PI Chair for Alcoholics Anonymous at our Workshop was very helpful and greatly appreciated by all of us. The spirit of cooperation, not affiliation, with AA is a trend that is long over due! The members of the WSC PI subcommittee who have put in so much time and effort to make this report what it is seeing the progress we are making with the help of a power greater than ourselves. What is clear to all of us working in PI is that we can't do it alone. We need and want the support and guidance of the Fellowship and trusted servants at every level of service within NA.

#### SUGGESTED DO'S AND DON'TS FOR AREA P.I. WORK

#### Review Material

DO's:

DO-- Know the traditions, especially #4, 6, 10, 11, & 12.

DO-- Be firm when communicating information about traditions.

DO-- Remember that no one member speaks for NA as a whole.

DO-- Follow established guidelines.

DO-- Be organized and follow through with your plan of action. DO-- Keep updated records of contacts and follow up regularly.

DO-- Realize your limitations - start with one or two projects and do them well before branching out. Remember, quality is more important than quantity.

DO-- Make sure that meeting lists are up to date.

DO-- Cooperate with other programs - AA, Nar-Anon, etc.

DO-- Have knowledge of resources available for help - other hotlines, emergency numbers and services, facilities, etc.

DO-- Follow up regularly on hotline postings and PSAs

- DO-- Try to get support--finances and man-power--from individual groups. (Perhaps hold own fund-raisers.)
- DO-- Poll groups to find out what services they want.

DO-- Update and screen speakers lists.

DO-- Present a good image of recovery (be on time, dress appropriately, avoid the use of obscenities etc.)

DO-- Start at the top, when contacting agencies.

- DO-- Get approval of projects from ASC and/or RSC's as far as resources and feasability is concerned.
- DO-- Communicate with RSC to keep them informed and ask for help.

DO-- Avoid controversial media contacts.

DO-- Keep media informed about anonymity.

DO-- Make information packets available.

DO-- Consult with members experienced in PI work before contact with the media and/or public.

#### DON'TS:

DON'T-- Do the work of another committee, such as H&I, make referals after initial request is made.

DON'T-- Affiliate with other 12 step organizations or treatment facilities.

DON'T-- Overtax your man-power and resources.

DON'T-- Burn out on a project before it is completed. This would project a very bad image of NA to the community and/or media.

DON'T-- Over step media boundaries as far as area-regional geography is concerned. When in doubt, ask!

DON'T-- Do it by your self, get help from the RSC. Remember the first tradition and that the service structure is there to be used.

DON'T-- Endorse or recommend specific treatment facilities.

DON'T-- Give out personal phone numbers on meeting lists or hotline bulletins.

DON'T-- Be naive in dealings with the media. Be aware of possible manipulation and exploitation.

The Policy Subcommittee is in the process of receiving input for the "Working Definition of Group Conscience" and "Carrying the Message."

#### "Carrying The Message"

This subcommittee is working in cooperation with the Literature Subcommittee on the pamplet "So you're a Trusted Servant". The Literature Subcommittee has a rough draft of the pamplet and it will be used as input for the work on "Carrying The Message". Also, an outline for a "Service Resource Manual", submitted by a member of the Board of Trustees, will be used as a starting point for a more complete Service Package. It should address the Why's and How's of service and should in no way conflict with the Service Structure now being considered by the WSC'84 "Select Committee on the Service Structure". Any member with 12th Step experience, including work with probation officers and judicial agencies (esp. the so-called card carriers), is asked to send their experience, strength and hope to the chairperson of this committee at the above address.

#### "Working Definition of Group Conscience"

The formulation of a "Working Definition of Group Conscience" is the Policy Subcommittee's first priority. The first step in this endeavor will be a questionaire distributed to various NA Service Committees regarding "Group Conscience". This information will be very valuable in formulating practical guidelines that can be used for future group conscience matters. The spiritual principle of "Group Conscience" need not be politicized, but some consensus needs to be gained for the fellowship to be capable of expressing our Higher Power's will. We utlize it for our group purposes and must constantly be on guard that our group decisions are truly an expression of God's will.

#### Policy Workshops

The Policy Subcommittee is asking any interested Regions to hold Policy Workshops for discussing and compiling written input on the "Working Definition of the Group Conscience" and "Carrying the Message". All Regional Service Committees or Convention Committees which would like a W.S.C. Policy Workshop scheduled in the next few months are asked to contact the chairperson of the Policy Subcommittee.

#### The Service Structure

All input relating to the Service Structure should be forwarded to the "Select Committee for the Service Structure" via W.S.O., Inc.

#### The WSC Policy Subcommittee

At this time, the subcommittee is composed of ten WSC'84 participants, including two Board of Trustees members. We will adhere to the guidelines as set down in the Temporary Working Guide to the Service Structure Pg.44 no.4:" Committees are composed of Conference participants who may appoint additional committee members as needed". The intent of this policy is to allow the

Policy Subcommittee to be a working committee. The Policy Subcommittee doesn't actually make policy, (pg.45 TWGSS). The purpose of this committee is to work with written input, i.e., to collect, clarify, define and state the decisions of the fellowship within our specific areas of concern and to initiate and coordinate actions based on these decisions (pg 42 TWGSS). Therefore, we need fellowship-wide input to collect and clarify, so that the Fellowship can decide what a "Working Definition of Group Conscience" is.

Any N.A. member, group, A.S.C., or R.S.C., either through your regional Policy Subcommittee or directly to the WSC Policy Subcommittee, is strongly urged to contribute written input. This includes suggestions for questions to be included on the "Group Conscience" questionaire. #### COMMITTEE FOR INTERNATIONAL AFFAIRS

#### DEAR FELLOWSHIP:

The Committee has been very active since the Committee was created at the Conference in April. The Committee met at the Conference and developed draft guidelines for the Committee, draft goals and draft of a statement of purpose for the Committee. The Committee members have been in communication

regularly.

One of the immediate projects the Committee undertook was to assist the developing Fellowship in Europe. The first multi-national activity to be held in Europe was held in late July in Dublin, Ireland. As Chairperson of the Committee, it was my honor to have been selected to attend this activity for the Fellowship. Unfortunately this report has been prepared prior to the event, but will arrive after the activity is over. So no report of the details of the meeting will be made until after I have returned.

Plans have been developed for providing additional assistance to the Fellowship in London, England with supplying on a regular basis the literature they need. The time required for transportation of literature is lengthy and only recently has a

regular resupply system been placed into effect.

Members of the Fellowship in France and Germany are working with the WSO and our Committee on the production of literature in French and German. The Little White Book and several pamphlets have been translated in both languages. The Fellowships in each respective country will proofread the material for accuracy and it can then be produced. Other languages will also be produced with the cooperation of members of the Fellowship on a similar basis.

The Committee and the WSO have broadened efforts at providing written communications to members of the Fellowship in foreign countries where there are no meetings. Letters are now carrying the N.A. message to members in Isreal, India, South Africa, Syr Lanka, Hong Kong and many other places. The Fellowship in Australia will be conducting a convention in September this year.

The Committee wishes to express our gratitude for the opportunity to serve the Fellowship.

### OPEN LETTER TO THE FELLOWSHIP OF NARCOTICS ANONYMOUS

Greetings from the members of the World Finance Sub-Committee; we hope that all Regions, Areas and Groups have now become familiar with our WSC '84 Fellowship Approved Financial Guidelines. They are now included in our Service Manual, "The Temporary Working Guide to Our Service Structure". The second edition of "The Temporary Working Guide" will be available after July 1, 1984 and can be ordered directly from our World Service Office. A WSO Order Form is enclosed. The need for and the approval of these guidelines are the beginning of our becoming more responsible with our money.

We want to continue building on the work begun by previous WSC Finance Sub-Committees. We are enclosing a copy of our review material of a proposed "Treasurer's Handbook". These procedures for keeping accurate financial records have been used by an Area Service Committee with thirty groups and its active sub-committees for one year. They have been used by one Region for six months. The treasurers report that these procedures, when followed step by step can be a tremendous help. By becoming familiar with the Area/Region bookkeeping system, the Treasurer benefits by not having to spend a lot of unnecessary time on bookkeeping. Reports indicate the group level procedures are helpful but may be to complicated. We believe the treasurer's work in our groups should be kept simple while being accurate. Many groups have checking accounts so the proposed handbook for groups includes procedures that make balancing a checkbook and bank statement easier. We hope you will use the material. Please help us with your ideas, suggestions, input and questions. Working together and sharing our experiences will insure our future stability and help make recovery more available.

Our World Service Conference and the WSC sub-committees need financial support. The WSC sub-committees carry the responsibility of implementing program procedures and literature that form the basis for our future growth. The work of the sub-committees determines the ease of success the Fellowship will have in carrying our message world-wide. The sub-committees are composed of recovering addicts and service on the sub-committees is expensive. For most trusted servants there are expenses related to operation of the sub-committee that the individual should not be expected to personally pay for. To meet our responsibilities the Fellowship as a whole should provide for these expenses. In recent years some of these valuable activities were not conducted or were delayed because funds were not available.

Page Two Open Letter to the Fellowship of N.A.

All of our WSC Sub-Committees have many service responsibilities. In Public Information we need to develop a comprehensive public relations program that includes audio-visual materials for radio, television, schools, public agencies, hospitals and institutions.

We need an improved H & I handbook. A coordinated program needs to be developed and implemented to help start more N.A. meetings within the Hospitals and Institutions. We need to continue to support our H & I Sub-Committee with funds so that literature will be more available to addicts seeking recovery in hospitals and institutions.

Our World Literature Sub-Committee has several books and informational pamphlets in various stages of development. The Literature Sub-Committee works very hard, but it takes a long time and a lot of money to produce literature.

In our International Fellowship there has been tremendous growth. Every effort must be made to assist those developing fellowships with materials in their own language. We need to establish a world-wide communication and literature distribution network.

Our Service Structure of N.A. has undergone a continual revision as a partial result of inadequate support of our world services. The WSC Selected Sub-Committee has been given the tremendous task of preparing a Service Manual.

All of our World Sub-Committees need improved guidelines and handbooks which will help us make recovery more available.

We all know that money collected in our Spiritual Fellowship has two purposes; to provide services that will help carry the message and to enhance the quality of our own recovery.

There are many, many addicts needing our help. Our world services can only be provided by our being self-supporting through our own contributions from our members, groups, areas and regions.

Our only adversary is addiction and we have the opportunity to provide services that will help arrest this disease. We hope that funds will begin to flow to support our world services.

We encourage fellowship wide WSC fund raising events keeping in mind our 7th Tradition and our spiritual principals. N.A. was founded in July 1953 so the WSC '84 approved a resolution that we have a world-wide birthday party for Narcotics Anonymous with funds going directly to the WSC. We hope this will begin this year. Money from such efforts will help each of us meet our service

Dear Barry:

In regards to our telephone conversation concerning people in the Fellowship of Narcotics Anonymous starting Hospital & Institutions (H&I) meetings on their own, we do appreciate their enthusiasm. However, it seems like whenever someone first gets clean, they want to go out and start an H&I meeting, whether it's in a hospital or in a jail, and it is through experience that we feel this inevitably defeats our purpose of serving the Fellowship. More specifically, we find people that do attempt doing this on their own have a tendency to "burn out" real fast, and once they "burn out", there is nobody to fulfill their commitments, and Narcotics Anonymous as a whole suffers.

We try to discourage people from attempting to set up committee meetings on their own. Instead, we request that people come to our H&I Committee Meetings and present their intentions to us as to how we can best serve that particular institution and then we can determine whether we have enough people to fulfill proposed commitments. With this in mind, perhaps you might consider making announcements and otherwise informing people in the Fellowship that you request they come to your H&I Committee with their requests and problems needing attention.

The World Service Board of Trustee's is very pleased with the results of the 1984 World Service Conference. It was a working, issue oriented Conference. Problem areas were identified and ground work was laid for solutions. The WSB has an enormous work load this year and we are already working hard on our tasks.

The WSB complained about last years stationery with its long list of names, addresses and phone numbers of Chairpersons, and Conference officers. We believe this constituted a violation of anonymity and in addition gave the message that power and prestibe were a part of service. Consequently the Board has decided that all mail for the Trustees should be sent through the World Service Office as our address above will provide. Additionally, phone calls for the Trustees will be routed through the WSO via a special phone number that has been installed for our use. During the day the calls will be answered by WSO staff. After working hours, the line is serviced by an answering machine. WSO staff will relay messages from direct calls or the answering machine to the appropriate Trustee.

Two areasin need of special attention of the fellowship were identified by the Conference: PI and H&I. The WSB is committed to providing specific assistance to these two WSC Subcommittees

in any way we can.

This Chairperson just returned from a PI Conference held in Boulder, Colorado. The meeting was very productive and there is an extensive report of the meeting in the PI section of this

Fellowship report.

The PI Subcommittee has developed a questionnaire to take an inventory of what has currently been done in the fellowship with respect to PI. If we can identify what is being accomplished in PI, the Committee can better determine what needs to be done. PI can then produce the resources or materials the Fellowship needsfor effective PI.

In addition to this questionnaire, PI is also distributing acensus questionnaire to determine the composition of our membership. This is important in order to assist PI in better carrying the message of recovery to the addict who still suffers. We urge full cooperation with PI in this matter.

At the World Service Conference, the Trustees Report detailed two meetings held between members of our Board of Trustees and of Trustees of AA. These meetings took place at the General Service office of AA in New York at AA's request. These

meetings were held in a spirit of cooperation, not affiliation. One result of these meetings, is that AA did a world wide mailing report on NA to their fellowship. NA has received several inquiries for information and meeting lists from addicts who heard about NA for the first time through this mailing. Subsequent to these first meetings other invitations have been extended by AA to attend AA Service meetings at the regional level to discuss PI and also H&I. These were referred to the appropriate NA region who sent representatives and gained information on how local H&I Committees might develop a permanent liason for referrals.

The World Service Office has also received requests to provide AA Central Offices with directories so that they can make referrals of addicts to NA.

The object of these discussions and attendance at meetings of AA is not to create an affiliate relationship in any way, shape or form. Much can be learned from them and the addict who still has not found NA may do so as a result of AA knowing how to refer addicts to us. We wish to continue to nurture the spirit of cooperation that began to develop with them last year.

Enclosed with this report are two sets of Minutes of Trustee meetings, one taken immediately prior to the conference and the second during the conference. Rather than waiting until after the next meeting to approve them, we used the mails to accomplish

this and as a result they are available much sooner.

The world Service Board meeting will be held in September at the World Convention in Chicago. This meeting currently has two issues on the agenda. One, the H&I sub-committee submitted a letter asking for clarification with respect to what constitutes an H&I meeting. Second, the World Literature subcommittee submitted the pamphlet "For Those We Love and Others" and asked the WSB for an opinion on it. In addition we have received input on "trusted servants" and "group conscience" and a request for extensive clarification. Further, the Board will discuss the the pamphlet "Am I an addict." These issues will be discussed in depth.

We would request at this time that if you have any item you would like to see the WSB take up at that meeting, please let us know in writing at least two weeks prior. In addition if there is anything you would like to see us work on this year, let us know. We welcome and actively solicit your input. We are looking forward to a very productive year and are grateful for the growth and progress of NA. WE are proud of this fellowship, many of us owe our lives to and are grateful for the opportunity to be of service.

DISC: Steve B.: Is a separate telephone line at the W.S.O. necessary. Bo S.: Why not a "Traditions Hotline."

DISC: Steve B.: Recommend that others (W.S.C. Administrative Committee and the Sub-committees) do the same. Sally E.: The recommendation is implied. The best teacher is a good example.

3. Committment to the Fellowship that all literature review now being done by the Trustees will be done in Workshop, with no more action done privately at home.

DISC: Sydney R.: There was much commentary on "Living Clean." Sydney R./Jack B./Sally E.: There were 34 pages of commentary on traditions violations (just to start).

M/S/C: To abide by Literature Review Workshop proposal. Unanimous.

DISC: re: Sally's report: Mike B.: We will continue sending any letters back to the regional level. Sally: NO If someone takes the time to write, they deserve a reply. Jack B.: We will continue to refer individuals back to the region, however, as part of the reply. Sydney R.: Also, we will capsulize answers and decisions for inclusion in the Newsline. Steve B.: Also, we need to be clear that our decisions are not "matters of law".

Q: Bo S.: Can we get from A.A. their files re: N.A. A: Sally E.: We have already received 43‡ of material form their archives.

DISC: re: meeting with A.A.: Bo S.: I am amazed that I just found out about the meeting. Sydney R.: The report from Dutch H. was omitted (in error) from the December minutes, along with the report on the proposed literature review workshop proposal. Bo S.: Request an inventory of the A.A. material. Sally E.: It's being done at W.S.O. Sally E.: special thanks to Dutch H. Jack B. (for his attendance at the Southern California A.A. Bo S.: We need to consider some vehicle to disseminate pertinent information for the Fellowship. Sally E.: We have the Newsline and the Fellowship Report.

Sally E.: Propose that W.S.B. state their dislike of the emblem and propose a change. Sally E.: Do we wish to state that the emblem is inappropriate?

M/S/C to state that emblem is inappropriate. Unanimous.

5. The word "recovered" vs. "recovering."

M/S/C to recommend blanket statement to use "recovering" at all times. Unanimous.

6. Re endorsement of Sydney's and Dutch's reports.

M/S/C to endorse reports. Unanimous.

7. Re Newsline schedules.

M/S/C to table until after W.S.C. Unanimous.

8. Re methods of answering letters.

DISC: Bo S.: We are receiving many, many letters. We need to provide a system for consistent emphasis and tone. Sally E.: We aren't getting that many letters anymore, and inquiries of a "new" nature are referred to the full Board for consensus (when there is no historic precedent). Jack B.: We have been in a bind before due to lack of preparation. Sally E.: We will eventually need a paid, fulltime secretary.

- Bo S.: We need correspondence guidelines. Sydney R.: We're putting such examples in the Newsline. Sally E.: W.S.O. is now doing all our secretarial/clerical/mailing work.
  - 9. re General Summaries on Traditions.

DISC: Sally E.: This is being done at W.S.O.

10. The proposed Literature Review Workshops.

DISC: Sally E.: If W.S.O. becomes our "treasurer" with authority to financially underwrite our services, we would have some travel expenses. Sydney R.: We are the only service arm without funds available, except the \$150.00 allotment received from W.S.C. Bo S.: There is a general need for financial support for service.

Mike B.: re the proposed literature review guidelines, at what point should the Trustees become involved? Sydney R.: In the guidelines, this would be just prior to the proposed literature being sent to the Fellowship for review and approval. There is an incredible need for a "review committee" for the Board of Trustees. Sally E.: Literature should come to the Trustees only after approval from the W.L.C. Literature Review process.

Mike B.: Do we need unity of opinion prior to W.S.C.? Consensus: Yes.

Mike B.: What is the role of W.S.B. Literature Review Committee in respect to W.L.C. literature Review? Sydney R.: We still aren't clear. Sally E.: If it becomes a standing committee, we can use it to do Newsline articles and other communications.

Bo S.: W.L.C.'s primary concern is with new production, but who goes through historic documents?

Sydney R.: Is there a need for W.S.B. to participate in the W.L.C. literature review process? Mike B.: Probably not. Jack B.: There is a definite problem with our service structure.

Dutch H.: The role of the W.S.B. committees will be determined by the way the W.S.C. committees define themselves. We have no position until they (the W.S.C. committees) define themselves.

Bo S.: Move that Sydney R. draft some guidelines for W.S.B. participation on W.S.C. committees. Sydney R.: We need to define the functions better first. Mike B.: Does the Fellowship want guidance from the W.S.B.? Sydney R./Sally E.: We can't write guidelines until the committees are better defined.

Jack B.: There are too many factors involved viz: location, cooperation, logistics, communication, etc. Sydney R.: Perhaps we can have a special meeting to discuss this relationship. Bo S.: Can we make a statement on the relationship? Dutch H.: Before we do anything, we need a statement on cooperation.

Sally E.: the problem is lack of definition within the service structure. We need a joint communication to the Fellowship following the W.S.C.

Bo S.: Moved to recommend that W.S.C. eliminate "co-chair" positions (Making only vice-chair positions) and that there be no duplication of positions at the World Service level. Sally E.: Recommend that we make a statement of policy only in respect to individuals holding more than one World Service position. Jack B.: Can we state that as trustees we will not hold multiple position, Viz:

"Trustees will not hold any additional service positions while members of the Board of Trustees and we recommend that all other World level trusted servants adopt a similar position of policy."

M/S/C to adopt above position. Unanimous.

Mike B.: What is the concern regarding the Trustees' vote? Sally E.: Let's not waste time. We all agree that we don't like "reaffirmation" or the "lack of vote".

Sally E.: This year we have an R.S.R. from Ireland. They (the Irish) really see a need for a Trustee for International Affairs. I would like to see a W.S.C. International Affairs Committee with Trustee participation. Jack B.: We can create the trustee position.

Mike B: Congratulations to Sally for an excellent job this year. Sally E.: Thanks to all of you (especially Sydney R. for the organization).

The Chairperson, Sally E. Welcomed the new members, John F., Bob R., and Shirley C. Packets of all previous minutes will be sent to each from WSO.

Elections were then held for the year 1984-85. Sally E. was nominated and elected Chairperson by acclamation. Sydney R. was nominated and elected Vice Chairperson by acclamation and Dutch H. was nominated and elected International Trustee.

Concerning Trustee Correspondence, Sydney noted that she and Sally get together periodically to answer letters. The typing of final drafts of the correspondence is done by the World Service Office. Sally appointed Sydney R. as her Corresponding Secretary.

Discussion was held regarding Trustee Liaison with World Service Conference Sub-Committees. It was noted that each Board member should keep other Board members informed of the activities of their respective assigned sub-committees.

Literature Committee - Standing Committee to take responsibility for Newsline and N.A. Way Articles; International Affairs; Training and Education; Policy and Structure.

Regarding the Literature Committee, Sydney clarified that working with Sally as liaison with correspondence is a tremendous task. There is a great deal of work to be done on Newsline Articles and maybe this should be broken down.

Bo read the list of Standing Committees.

Bob R. asked if we needed guidelines for Standing Committees to help us understand what we need to do. There was discussion regarding how the Standing Committees should function.

It was M/S/C "That this year we spend on defining what things sub-committees are going to do and How to do it."

Steve B. mentioned that seeing these things on paper is one thing and trying to do them is another. He stated his experience with International Affairs.

There was discussion about purpose, intent, guidelines and directions in which way to go and how to do this most effectively understanding conceptually what to do.

Long Range Planning and Guidelines should come from experience. All Board members to assist each other and perhaps we'll all have to help on all committees. Sydney is to work with Literature Chairperson and find out her need.

It was stated that this was the first year we were really involved. Now, what do we need right now? i.e., External Affairs and AA - What is the need? Fellowship to present needs. Literature - Simply write Articles. Training & Education - Committee that would, if WSC had 4 conference during the year, work with conference on Training workshops.

The Chairperson stated that she does not want to do it all. Bob R. stated that he does not want to get into Sub-committee affairs. Discussion included the fact that there is no need to duplicate efforts and try to do things set aside from WSC Sub-Committees. Because of our new concept, we should establish a purpose and intent for each of our committees.

Discussion was held regarding the following subjects: Newsline Articles Responsibility - Bob R., Conferences at Workshops - as

needed.

Since too many people get involved in Trustee Meetings at conventions, there should only be Trustees at a <u>regular</u> Trustee meeting at conventions, and the meetings should not be open for Fellowship participation and input. We need to adhere strictly to our agenda. Fellowship may be onlookers, not participants.

It was discussed and decided that any motion regarding travel expenses should come from the floor and Sally will speak to the conference in favor of it.

There was discussion regarding the telephone budget and it was estimated that we will need \$300/mo. Sally will need \$50.00 and balance for intl. calls.

The schedule of Board meetings for 1984/85 was discussed and the Board unanimously voted to hold 3 meetings in the Los Angeles Area - November, February and May, and a meeting at the World Convention in Chicago. If there are "mini" World Service Conferences during the year, Board members living closest will be assigned.

Travel expenses for Board Members living outside the Los Angeles area were discussed. Members present spent the following sums for plane fare to get to this conference:

If this comes up on the floor of the conference, Sally will proceed according to the consciousness of the Fellowship regarding travel expenses for Board members to California - and all members to the World Convention.

There was discussion regarding written reports for Fellowship Reports, and it was decided that each member should make a written report 4 times a year for inclusion in the minutes, and Fellowship reports including the details of their activities for the three months preceeding the Board meeting.

Mike said he would like to write guidelines regarding the role of the Non-addict on the Board of Trustees. Dutch suggested that each member make a 3-minute report of what we did during the year at the World Service Conference next year, and the new Chairperson should be told we would like to do that so he can put it on the agenda.

Upon motion made, seconded and carried, the meeting was adjourned shortly after 1:00 pm.

The Ad-Hoc Committee met first at the conference in Los Angeles, and then in Knoxville, Tenn. June, 1984, at the Special World Literature Conference. There, the revised guidelines were completed and are included in this report.

The second draft of our Steps & Traditions were completed at the Literature Conference. It will immediately be sent to the Literature Review Committee where our first priority will be to review this draft for Tradition violations, philosophical discrepancies and language in cinsistant with Narcotics Anonymous terminology. The Literature Review Committee will then send their corrections, evaluations and suggestions back to the World Literature Committee so it can be considered for input at the next Literature Conference to be held in San Diego, November 1984.

We're simultaneously sending the revised guidelines to the Ad-Hoc Committee for further input. If there are changes, the Fellowship will be notified in the next fellowship report. will be evaluating these guidelines untile we have the completed draft. The completed draft will then be ready for our last fellowship report and input to World Literature Conference 84-85.

At this time I'd like to express how pleased I am with the progress the Ad-Hoc Committee and Literature Review Committee are making. I feel the work and the cooperation shown will continue to grow through the coming year.

# PROPOSED REVISION PROCEDURAL GUIDELINES FOR THE CREATION AND DEVELOPMENT OF NEW LITERATURE

#### I. PREPARATION

- A. New raw material is obtained from any source. Release forms must be secured from any member contributing material of any type, especially that which may be construed as a personal story or experience. There is one standard release form used by the fellowship for all purposes. Copies can be obtained from the WSC Literature Committee Chair or Secretary or the World Service Office.
- B. The WSC-LC uses the following criteria in determining if a particular piece of literature is appropriate and needed by the fellowship:
  - It supplies valuable information to the medical profession, business community or clergy in clarifying the nature of addiction and aiding in the addicts recovery.
    - 2. It carries the message of Narcotics Anonymous to the addict who still suffers.
- C. In conjunction with the World Literature Committee, area and/or region literature committees choose projects or volunteer to help with current works-in-progress.
- D. Resource or reference material from the WLC files may be sent to the literature committee upon request. These committees may include but are not limited to local, area or regional literature committees or any committee dedicated to carrying the message in written form. The committee compliles the input and draws up a draft. (For more information, see Lit. Committee Handbook.)
- D. The completed rough draft is then sent to the WSC.

## EVALUATION CONTRACTOR OF THE PROPERTY OF THE P

- A. All drafts received by the WLC by July are printed in Evaluation Form and distributed to the Literature Review Committee (LRC) (See Appendix A) for evaluation based on the following criteria:
  - 1. Accurate representation of the Twelve Steps and Twelve Traditions.
    - 2. Philosophical discrepancies. The philosophical discrepancies.
    - 3. Spelling, grammar, punctuation.
    - 4. Consistency of style.
    - 5. Language consistent with Narcotics Anonymous terminology.

A more specific description of the evaluation process is contained in the System for Literature Review (See Appendix B).

- B. During this same time period, the Evaluation Form drafts are also sent to the Registered Active Member (RAM's) (See Appendix C) of the World Literature Committee for evaluation.
- C. Evaluation by both the LRC and RAM's includes the designation of one of these three catagories:
  - Category "A" Distribute to the Fellowship for review.
  - Category "B" Needs more work prior to review by the Fellowship (input is attached and the input is addressed at a WLC Conference).
  - Category "C" Discontinue to work on this draft and channel material to WLC resource files.

The length of the evaluation period is determined by the WSC-LC Chair based on the nature and priority of the literature piece.

- D. Mailed responses are tallied by the Chair and Secretary of the WLC.
- l. If there is no input from the LRC, a simple majority of responses in category "A" initiates the review process.
- 2. If there is input from the LRC, or less than a majority of responses designating the draft in either the "A" or "C" categories, the draft enters category "B" with a subsequent workshop process.
- 3. If 2/3 of either group votes for designation "C", then work is discontinued and the draft is placed into the WLC resource files.

### III WORKSHOP PROCESS

- A. All Category "B" (needs more work) drafts are placed on the agenda for the next World Literature Conference. Priority is given to those drafts which received a large number of "A" responses, but not a majority. The revised draft, resulting from the workshop, then returns through the evaluation process as outlined in C and D above.
- B. Category "C" (discontinue work) drafts that did not receive a 2/3 majority are placed in the category "B" (needs more work) with low priority at the World Literature Conference.

#### IV. REVIEW PROCESS

Fellowship Review Α.

All Category "A" drafts are printed in Review Form and distributed to the Fellowship. This is also an invitation to the Fellowship for input based on the following questions: Is the material acceptable as is?

- What should be added?
- What should be left out?
- What should be changed?
- Should work on this material be discontinued? There is a minimum period of nine months for receipt of review input by the WSC-Literature Committee Chairperson.

## V. APPROVAL PROCESS

- Input received on Category "A" Review Form drafts is implemented into a revised draft at the next World Literature Conference. The draft is carefully edited and proofread before it is printed in Approval Form. (Any additional input subsequently reveived is kept in a file for consideration in revision. Paragraph V, e).
- Immediately following the World Literature Conference, the Approval Form draft is forwarded to the WSB to ensure that it accurately represents the principles of Narcotics Anonymous as outlined in the Twelve Traditions. Within 90 days from receipt of the draft, the Board of Trustees responds in one of two ways:
  - Points out any section(s) contrary to the Twelve Traditions or;
  - States in writing that the material is consistent with the Twelve Traditions.

Determinations by the WSB of tradition violations are automatically revised in the preparation and distribution of the Approval Form Draft.

- C. The printing and distribution of the Approval Form draft is accomplished by the World Service Office. The Approval Form is distributed to the Fellowship for approval or disapproval. conscience votes are taken through Regional Service Representatives at the World Service Conference.
- D. If the work is not approved, the material returns to the World Literature Committee for further evaluation and revision.
- Each piece of WSC-approved literature is evaluated every five years for consideration of revision at a World Literature Conference.

## APPENDIX A LITERATURE REVIEW COMMITTEE

A literature Review Committee (LRC) composed of not more than seven members shall work closely with the World Literature Committee Chairperson at all times. Each member shall serve for a term of three years, and may be reaffirmed for consecutive terms by the WSC.

Purpose:

To review proposed literature compiled by the World Literature Committee.

#### Suggested Qualifications:

a) Five years clean time.

- b) Experience in applying the Twelve Steps and Twelve Traditions.
- c) Extensive experience in working with the literature of the Fellowship on an area, regional and world service level.

#### Literature Review Committee Composition:

- a) Three members chosen by the Fellowship at large at the World Service Conference.
- b) Two members chosen by the Chair of the World Literature Committee. (Past chairpersons of the WLC may be considered for a service position on the Literature Review Committee.)
- One member of the committee is a Trustee of the appointed World Service Board of Trustees, to help filter out tradition violations and legal problems that may be present upon initial review. The Trustee shall work closely with and serve as a liaison between the World Literature Committee Chairperson and the World Service Board of Trustees.
- d) The WSC-LC Chair shall serve as a member of the LRC.
- e) No more than one person from one geographical region may serve on the LRC, except in the case that these members may be necessary to maintain open communication and unity.

The World Service Office has evolved during the last year into an efficient, well-run arm of the Fellowship. The general responsibilities assigned the World Service Office, including publication and distribution of literature, registration of new groups and responding to general inquiries about Narcotics Anonymous have become well organized enough that those duties are discharged accurately on a daily basis with no difficulty. The office staff is to be congratulated for the tremendous improvement. Additionally, responsibilities assigned to the World Service Office by the Conference in April 1984 have similarly been approached with diligence and hard work. Major tasks currently facing the office include; publicattion of the N.A. Way Magazine, reprinting the Basic Text, and special printing of N.A. literature.

The office has just concluded a search throughout the Fellowship to select and hire an editor for the magazine. Thirteen applications or inquiries were received. The person selected was clearly the most qualified applicant. He is a 5 year member of the Fellowship, currently serving as RSC for the Upper Midwest Region. He has a Bachelors degree in Counseling. He has been employed during recent years in rehabilitation and counseling programs, and has developed considerable skill in the field of rehabilitation counseling. These unique qualifications will be of great benefit to the Fellowship. His name is Ron Hofius and he will be moving to Los Angeles when he has completed his work on his Masters Degree, later this year. He is currently on staff working part time and supervising the publication of the Magazine. The June issue of the magazine was mailed during June and the July issue is expected to be mailed by the last day of July. A draft copy of the August issue is currently being reviewed by the review panel. The September draft will be sent to the review panel in early August. It is expected that the magazine will, by October, be distributed during the first week of the month the magazine is due. Strong effort will be exerted in the months ahead to substantially increase the number of subscriptions. Soon after the Conference ended, the World Service Office began to accomplish printing of the 3rd Edition of the Text. There was, of course, a delay in final typesetting pending results from the Fellowship of the vote on the 4th and 9th Traditions issues. That is complete and we should have been able to go ahead with printing the 3rd Edition. However, a new problem has arisen concerning final language of 3 stories. During the proofreading session of material to be included in the Text (work the typesetter had previously completed), it was discovered that changes should be made in 3 stories. Proofreading was halted on these stories at the request of WSC Literature Committee until such time as the Literature Committee was able to study these stories and make corrections in grammer, punctuation and, in one story, correction of Tradition violation. The Literature Committee completed this in their workshop in Louisville, Kentucky in early July. The World Service Office has now found ourselves in the situation encountered two years ago; we are being asked to print 3 stories either in a form which is uncorrected and therefore replete with errors in grammer and punctuation which have been approved by the Conference, or print corrected versions which have not been approved by the Conference. This issue is being studied by appropriate Fellowship Trusted Servants, including Trustees, to determine the correct course of action. Consequently, the production schedule for the 3rd Edition has been delayed while this matter is resolved. The office currently has sufficient copies of the 2nd Edition to meet the Fellowship needs for quite some time, so no damage is likely to occur by this delay. But it is important for the Fellowship to know that the 3rd Edition cannot be printed until the matter is resolved. Presuming that the issue is solved reasonably soon, the 3rd Edition could be printed and available in November.

Special printing of N.A. literature includes translation into foreign language, production of literature in Braille and on Audio Tapes. the World Service Office received and has in stock the White Book and 5 pamphlets in Braille. World Service Office had 500 copies of these produced. The White Book and pamphlets have been entered in the catalog system as material available in Braille for all libraries in the country that handle Braille materials. W.S.O. plans to distribute copies to regional public libraries that handle Braille materials. Braille materials are considerably more expensive than regularly printed pamphlets, consequently, W.S.O. feels it is important that the entire Fellowship know that these Braille materials are available, but ask that they not be requested unless members or potential members actually make a request for literature in Braille. No price has yet been determined for these materials.

#### Page 3 - To The Fellowship

They will, however, certainly be sold for less than our production cost in order that they can be made available to individuals without causing substantial financial impact. World Service Office has received from our translators the White Book and pamphlets in both German and French. These literature items are currently being typeset and should be returned in early August. The typeset drafts are going to be proofread by members of the Fellowship in Germany and France prior to the actual printing of these materials in quantity. The target date for availability of these literature items is late September. Translations into Italian and Castilian Spanish is scheduled for September. Arrangements have been made to begin tape recording the Text, White Book and pamphlets in September. Presuming this production schedule is followed, these materials should be available for sale in November.

Because of the tremendous and previously unexpected substantial growth of the Fellowship, the whole concept for publication of the World Directory is being re-considered. Last year, when the publication scheme for the World Directory was adopted by the W.S.O. Board, unknown was the question of how many individual changes would be included in each quarterly update. The number of changes has proved to be so extensive that a two year schedule for printing a completely revised Directory may not be practical. The Board will be considering changing that policy back to a yearly schedule with updates quarterly. Also considered will be a policy of not including a meeting in the directory until it has been in existence for 6 months. The Fellowship's input on these directory ideas would be appreciated.

#### MEMORANDUM

DATE: July 3, 1984

During the World Service Conference in April, I was presented with an accumulation of records (receipts, bills, checkbook, bank statements, etc.) from Joseph Proctor III. These records were, he explained, the records of his service as Treasurer of the World Service Conference 1981/82. He informed me he had attempted to present the information to the outgoing Finance Committee Chairperson. The outgoing Chairperson had indicated to him and subsequently informed me that the Committee was not going to conduct an audit of these records, even though no conclusive report has ever been prepared on these financial records.

There is, in my opinion, no responsibility or obligation on the part of World Service Office to conduct an audit or make a report on these records. However, in as much as, there has been considerable complaint about non-receipt of the records and a lack of an audit, I believe that the record should clearly state the information is currently available.

I do not believe there is any practical benefit to the Fellowship that would necessitate an audit of these books. As I indicated to Joseph Proctor III, at the time, I will store these records along with the other historical information for the Fellowship.

Way Sub-Committee had failed to provide me with information necessary for the preparation of a financial report of their activities for the past year.
